This special package is available to business that meet the following criteria. If you do not, or are unsure, just call (07) 3366 1566 and we will help solve your insurance problems.

YOU MUST:

- Be a mobile telephone retail outlet
- Have had less than 3 reports or notifications of liability claims against you in last 3 years
- Not have experienced incidents or claims that would have entitled them to claim a total of more than \$7,500 in the past 3 years
- Not have experienced incidents or claims relating to flood
- Not have had any insurance contract denied, cancelled, nor been subject to special conditions in the past, and/or the proprietor convicted of any criminal offence other than driving offences
- Trade in a building constructed with brick or concrete
- Trade in a building which is less than 60 years old, or which has been rewired in the last 10 years or been thermographically scanned in the last 2 years with no defects recorded
- Trade on a premises that is protected by at least the following: Securitel monitored alarm system, doors equipped with double cylinder windows dead bolt locks, windows equipped with tamper proof locks and bars; roll down gates across shop fronts/entrances or shutters on all windows and doors - this is not required for stores inside sprinklered shopping centres with no high street access, that are secured by doors after hours
